The Phoenix Indian Center's **Living in 2 Worlds** workshop provides a resource for American Indian youth and aims to ensure the well-being of American Indian youth in their home and school environments. The curriculum, **Living in 2 Worlds**, draws on Native culture and values as effective drug resistance strategies. ### WHAT IS LIVING IN 2 WORLDS?

The **Living in 2 Worlds** Summer Day Camp is open to middle school-aged students who will be entering the 6<sup>th</sup> grade up to entering the 9<sup>th</sup> grade. The **L2W** Summer Day Camp will begin Monday, June 5<sup>th</sup> and end Thursday, June 29<sup>th</sup>. It will take place four days per week (Monday through Thursday) from 8:45 am to 4:30 pm. Students can arrive as early as 7:30 and picked up no later than 5:30 pm. Breakfast will be offered from 7:30 to 8:45 am. Participating youth will be fed through the local school's free lunch program, or they can provide their own lunch.

The **Living in 2 Worlds** curriculum was developed by the Phoenix Indian Center in partnership with ASU's Southwest Interdisciplinary Research Center using the **Keepin' it REAL** drug resistance strategies project as a program for our American Indian youth. **Living in 2 Worlds** draws on American Indian culture and values as effective drug resistance strategies. We provide youth with different ways to say no to negative choices that confront youth every day, and at the same time, we give youth ample opportunity to express their pride in their American Indian culture(s) and teach them the positive value in the nurturing of that pride.

<input type="checkbox"/>	<p><b>Pre- and Post-Program Surveys:</b></p> <p>The survey will gather information on attitudes, thoughts, and behaviors around use of substances, such as alcohol, tobacco, and other drugs. A copy of the actual surveys used to evaluate this program can be provided to you upon request.</p> <p>Your son or daughter's participation in the evaluation is voluntary. Students who are given permission to participate only have to answer the questions they want to answer, and they may stop taking the survey at any time. Refusal to participate in the evaluation survey involves no penalty, and your child will still be permitted to participate in the program.</p> <p>All personal information collected in the surveys will be kept private. The only place in which your child's name will appear will be on this registration form, and names of individual students will never be shared with anyone not affiliated with Living in 2 Worlds Day Camp or Phoenix Indian Center. The results from these surveys help to improve the curriculum and program.</p>
